**Curriculum development:**

2022; Part of a curriculum development team of CoJMC faculty who advise on updated changes to the JOUR200A Beginning Reporting course in our college. The goal of JOUR 200A is to give students a strong foundation in journalism, editing and writing. It also gives them some introductory reporting experience. JOUR 200A's objective is to improve student writing and editing skills to prepare them for upper level CoJMC classes in journalism, broadcast, public relations, advertising or sports media. This course includes discussions, editing exercises, style and grammar quizzes, peer editing, basic story writing, interviewing and written reflections on case studies in journalism ethics.

2021; Created curriculum and syllabus for a 15-week News Literacy class that will be taught in the spring 2022 semester. The JOUR391 news literacy course is designed to teach students to exercise their power as citizens by becoming more perceptive news consumers. Armed with critical-thinking skills, a firm grasp of relevant history and practical knowledge about the news media, JOUR391 News Literacy students learn how to find the reliable information they need to make decisions, take action, make judgments and responsibly share information through social media.

2021; Revised curriculum development for broadcast sequence. Reversed 2018 merger of BRDC370 and BRDC371 broadcast writing and videography courses and updated syllabi to create two three-hour courses- one for audio news reporting, the other for video news reporting. This created more time for students to get experience learning how to report and tell stories using audio and video. This was approved by the broadcast/journalism sequence and overall CoJMC faculty.

2018; Revised curriculum development for broadcast sequence. Created a merged curriculum of our BRDC370 and BRDC371 broadcast writing and videography courses which combined two six-hour courses into one three-hour course. It created more flexibility for students to choose additional courses in the broadcast major and was approved by the broadcast/journalism sequence.

## Creative: Documentary and long form reporting

My documentary and long form reporting work has been substantive, peer-reviewed, and a recipient of international, national and regional awards. They have been viewed or listened to by hundreds of thousands of people. They are truly collaborative arts that have involved many talented and creative collaborators. Ultimately though, I have been responsible for most of the work and major decisions in these projects. A writer/director/producer/ of a documentary or long form report must not only get the story

right, but clearly form the aesthetics of the story too. It's "boots on the ground" work. There are no typesetters or book designers to decide the type face or organize the layout of my work.

Several years as a professional broadcast, print and web journalist have allowed me to report and produce long form and investigative reports. In 2006, my focus shifted to documentary production and long-form storytelling when I began teaching in the College of Journalism and Mass Communications. Since then, I have spent an estimated 5,000 hours working as a producer, director and associate producer on four hour-long documentaries and several long form radio and television reports that aired on television stations and cable networks, screened in Nebraska, Missouri, Kansas, Michigan, Ohio, Illinois, North Carolina, Texas, Idaho, and California, and distributed on Amazon Prime Video.

Nebraska-born U.S. Army public affairs officer, spearheaded the bronze statue's repatriation. Calling it one of his strangest experiences in "peace or war," Oldfield wrote that the Isted Lion held the same "emotional, sentimental and patriotic meaning" for the Danes that the Statue of Liberty had for Americans.

Thirty years later, I contributed a lead report for a KCTV5 news special that explains what happened the night the skywalks fell. It featured interviews with the emergency medical response doctor who directed the triage operation, survivors, rescue workers, the hotel's architect and former Kansas City, Missouri, mayor Richard Berkley. Besides working with the CBS affiliate to locate and identify archival materials and interview guests for the television special, I was interviewed for a segment in the news special regarding my own experience covering the disaster as the TV station's first reporter on the scene.

Most people mark the passage of time with watches and calendars, but migrating birds mark time by cold and warmth and length of day. It tells them when to begin their migrations across North America. Just east of Rulo, Neb., Squaw Creek National Wildlife Refuge is a major stopover for those migrating birds.

2023, Currently researching, writing and producing a half-hour documentary for Nebraska Public Media on Robert Reuben. The Nebraska-born Reuben was the first correspondent to parachute into France six-hours before the D-Day Allied invasion of Normandy. The documentary's working title is "Running Towards the Fire." It will take a deeper look at the important and often dangerous role war correspondents plays in WWII. The documentary is scheduled to broadcast in winter of 2024.

2023, Nebraska Public Media, Researched, produced, reported and narrated a television documentary short on Beverly Deepe Kever for "Nebraska Stories." Kever was the longest serving war correspondent in the Vietnam War. 2017-2018. "[Black Jack Pershing: Love and War](#)" began broadcast on Nebraska and Missouri public television stations in November, 2017. A 2018 winner of a national Sigma Delta Chi journalism award, the documentary has screened at the National Archives and Records Administration in Washington, D.C, the GI Film Festival in San Diego, the Kansas International



Film Festival and National WWI Museum in Kansas City, the San Francisco Film Festival and dozens of other national venues.

National distribution of the documentary began on Amazon Prime Video in early 2018. I am producer/director of the project which introduces audiences to General John J. Pershing, who commanded U.S. troops in World War I.

Pershing tipped the balance of the war in favor of the Allies. By doing so, he helped open the door for America's ascendancy as a 20th century superpower. Production budget on the 4-year project was \$250,000. The documentary has been endorsed by the U.S. WWI Centennial Commission.

Today, few Americans know about Pershing's devastating tragedy that took the lives of his wife and three daughters. Few Americans know what huge obstacles Pershing faced and overcame to help turn the World War I battle tide. Ultimately, Pershing persevered and positioned America's military as a respected global force. He memorialized American sacrifices on foreign soil, and mentored the generation of military leaders who guided America in World War II.
